



THE SURVEY REGULATIONS 1959, AMENDMENT NO. 1

PURSUANT to the Surveyors Act 1938, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, and on the recommendation of the Survey Board, hereby makes the following regulations.

REGULATIONS

1. These regulations may be cited as the Survey Regulations 1959, Amendment No. 1, and shall be read together with and deemed part of the Survey Regulations 1959* (hereinafter referred to as the principal regulations).

2. Regulation 16 of the principal regulations is hereby amended by inserting in the second proviso, after the words "or compass surveys", the words "or from aerial photography".

3. Regulation 36 of the principal regulations is hereby amended by revoking paragraph (d) of the portion thereof relating to Procedure, and substituting the following paragraph:

"(d) Land plans prepared on the instruction of a District Commissioner of Works or by any officer to whom he has delegated the requisite authority, and land plans prepared for a local authority of a new State highway or deviation of any existing State highway, shall have endorsed thereon the consent of the District Commissioner of Works or of that delegated officer, as the case may be, before being approved as to the survey by the Chief Surveyor."

4. Regulation 36 of the principal regulations is hereby further amended by adding to the portion thereof relating to Procedure the following paragraph:

“(e) All land plans for new railways shall have endorsed thereon the consent of the Commissioner of Works, and all plans of additional land on existing railways shall have endorsed thereon the consent of the Chief Civil Engineer of the New Zealand Government Railways Department, before being approved as to the survey by the Chief Surveyor.”

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

The amendment to regulation 16 provides for the use of aerial photography to define natural features.

The amendments to regulation 36 redefine the procedure relating to the examination of plans, and clarify the responsibility between Government Departments and local bodies.
